128.3 Internal/External Audit 2021-22

Members noted that both the internal and external audits for 2021/22 have been completed. In terms of the external audit, the Parish Council

declared itself exempt from audit and this was accepted. In terms of internal audit, the report from the auditor was as follows: -

Completed the internal audit of Cholmondeston and Wettenhall parish council and completed page 4 of the AGAR form. The accounts were fine and well presented but there are two small matters I should draw to your attention;

- I could not reconcile the payments to HMRC with the tax data included in your file. The accounts reflect the payments actually paid in the year so I have certified the accounts. No doubt things will become clear in the cash book for the current year.
- The council have now paid a further £57.30 VAT this year. This added to the £166.25 VAT paid last year means there is now £223.55 which is recoverable from HMRC. I would recommend that you submit a claim as soon as possible
