134. APOLOGIES FOR ABSENCE

Apologies received from Cllr John Woodward (JW) and Cheshire East Cllr Sarah Pochin (SP).

135. DECLARATIONS OF INTEREST

There were no declarations of interests were made by Members at the meeting.

136. MINUTES – 5TH OCTOBER 2022 (PARISH COUNCIL MEETING)

The minutes of the Parish Council meeting held on 5th October 2022 were presented to Members for approval.

The Council **RESOLVED** to approve the minutes.

137. MATTERS ARISING

The following matters were raised at the meeting from the above minutes.

- Delphic Transport it was reported that there had been some issues regarding HGVs in the area and potential damage to the local road network. No further information had been received from Church Minshull Parish Council and no further information from any other source.
- Former Boot and Slipper site the latest date for completion is now Easter 2023
- Village Green Plans yet to be tided up and confirmed formally got the land but the technical/legal issues are yet to be sorted out.

138. PUBLIC FORUM

Eleven members of the public were present at the meeting – the following issues were raised.

 Gritting – a resident asked about the latest situation. It was reported that Cheshire East Council had decided not to grit roads in the parish including Long Lane/Winsford Road. It was further reported that the Parish Council had made representations but this had made no difference. Signs are in place, but no gritting is taking place. Grit bins have been sited and CEC has been contacted about this in terms of health and safety and whether the public should be gritting roads themselves. No response has been received on these points. The Chair advised that members of the public should contact CEC with complaints about this issue.

• Planning – a number of comments were made about Planning Application 22/4413N and these are included in the minute on this item.

142. PLANNING MATTERS

Members considered planning issues affecting the Parish.

142.1 Planning Application

The Parish Council has received notification of the following planning application.

22/4413N Land Adjacent to Long Lane, Long Lane, Wettenhall CW7 4HH

Material change of use of land from stable block, menage and use of land for equestrian use to a mixed use of stables, menage, use of land as equestrian and the siting of caravans for residential purposes and the erection of two dayrooms together with associated hardstanding.

The Chair reported that Cllr Sarah Pochin had called the application in for consideration by the Planning Committee at Cheshire East Council. No developments in the process had been reported at the time of the Parish Council meeting. The Chair also reported that confirmation of the result of the call-in is being awaited.

It was further reported that there had been numerous objections to the application from members of the community, but that more people could provide objections.

It was noted that one resident had incurred costs to obtain legal advice on this matter and there had been contributions to the process from other residents. This process had highlighted issues with the application itself.

The Chair commented that there had been concerns that work could be done with or without permission due to inaction from Cheshire East Council. A resident commented that people should not underestimate the resources available to the applicants throughout the process including the potential for appeal.

PB left the meeting.

A resident asked whether other parish councils need to be informed about this matter. The Chair said that councils such as Alpraham, Darnhall and Eaton could be informed.

The Parish Council agreed that it would object to the application and submit comments to Cheshire East Council.
